We have also received a complete record of votes cast through electronic mode, upto 5:00 p.m. on 03rd January. 2021 from NSDL e-Voting System, the agency appointed for providing and supervising electronic platform. The votes east were unblocked on Monday, 04th January, 2021 at 10.20 a.m. (IST) in the presence of two witnesses who
